



CALL FOR NOMINATIONS FOR LAI FALL 2020 INTERNATIONAL FELLOWS

Presented at the Fall LEW in Los Angeles, CA
September 12, 2020
Nomination Deadline – February 28, 2020

This is an invitation to all members of LAI but especially to Chapter Presidents (who may wish to consult their executives or members) and members of the Executive Committee to nominate candidates to be named a *Fellow of Lambda Alpha International*.

Fellow Candidates are to be approved at the Spring LAI Board of Governors (BOG) Meeting (Chicago April 20, 2020) for receipt of the honor at the Fall Land Economics Weekend closing dinner (Los Angeles September 10-12, 2020).

Nomination Criteria:

The designation of new Fellows is limited by the By-law to two (2) per year. Candidates for nomination consideration can be drawn from any member of the Society.

Such a designation should reflect years of substantive dedication and service to the Society whether at the local Chapter or international level and would honor only those whose dedication is noteworthy, advancing the goals of LAI within the framework of its organization, including that of the Land Economics Foundation, as set forth by Richard T. Ely and the LAI and LEF By-laws.

Candidates for the Fellow membership class status in LAI are distinctive, honorific and differ from recommendations for emeritus status recognition under the LAI By-law.

The nomination of a candidate member for designation as a Fellow can be considered for all who satisfy the qualifications for such designation without discrimination on the basis of gender identification, sexual orientation, racial identification, age, ethnicity, spoken language, religious affiliation, citizenship or national origin.

Nomination Requirements:

The nomination shall be accompanied by as full and complete documentation available of the reasons as to why the candidate is being advanced for recognition by the BOG as a Fellow of LAI.

As a general rule, no candidate is eligible for nomination if he or she is an officer, director or assistant officer (i.e., any member, except for persons attending occasionally in the capacity of a Committee Chair) of the LAI Executive Committee or is a Chapter President and member of the Board of Governors, in the nomination year.”

Timing:

The nomination material shall be submitted to Sheila Hamilton, LAI Executive Director, **by February 28, 2020**. Questions may be directed to her as well.

Nomination(s) received will be voted on by the Fellows for the recommended Fellow nominee candidates to be submitted to the Board of Governors, by March 27, 2020.
