LEF GRANTS THROUGH TIME

LEF grants funds to non-profit organizations and professionals to study a wide range of topics concerning land economics. Awards have been granted throughout the United States and, more recently, internationally. Starting this past year, video presentations by recipients have been made available in Keynotes. Very often, LEF grants are combined with grants from other organizations, thus allowing larger projects to be undertaken.

This year, at the LEW in San Juan, Puerto Rico, the LEF Committee approved grants for four studies, all of which are described in a separate article by LEF Vice President Jon DeVries.

Ron Buss (LEF President) and Rachel Edds (LEF Treasurer), members of the LEF Board compiled a list of grants awarded since LEF began its program in 2006.

The velocity of submittals has increased recently, much of it due to the efforts of Jon DeVries, LEF Vice President. As well, the submittals have been from a broadened range of chapters and locales.
